**Venue-Specific Accreditation Application Procedure:**

- The BCCI's affiliated units will only accept **HARD COPIES** of the Venue-Specific Accreditation form.
- Each application should be accompanied by the following:

A letter of endorsement/authorization from the Editor/Sports Editor of the Publication / Group that the applicant represents

A copy of the applicant's photo-ID (PAN card / Driving licence / Passport).

Each applicant must include two colour passport-sized photographs with his / her name clearly printed on the back of each photograph.

- Additional evidence of recently published work may be requested by the BCCI for further support any application for accreditation. Similarly, once accreditation has been issued, accredited mediapersons may be asked to substantiate their cricket coverage by providing evidence of their published work.
- The BCCI reserves the right to decline applications for accreditation without assigning any reason.
- Applications for accreditation by websites, radio stations, electronic news agencies and production houses will not be accepted.

**Terms and Conditions/Ground Regulations:** Access and accreditation is subject to the BCCI's guidelines (note attached) and appropriate ground regulations.
