

FORM OF BOUNDEN AGREEMENT

Articles of Agreement executed on this day of Two Thousand and Twenty One Between the KOZHIKODE DISTRICT CRICKET ASSOCIATION (a unit of Kerala Cricket Association) acting through the Honorary Secretary, Kozhikode Dist. Cricket Association, Al Falah Building 2nd floor Opposite Govt. Beach Hospital Kozhikode - 673032 , hereinafter referred to as ‘the KDCA’ of the One Part And Sri/Smt

WHEREAS in respect of the invitation for tenders, contained in Notification **No..... /2021 / dated.....** inviting tenders, the Bouden has submitted to the KCA a Tender for the work **“Construction of Indoor Net facility at Sri. NOW THESE PRESENTS WITNESS AND it is hereby mutually agreed as follows:-

1. In case the Tender submitted by the Bounden is accepted by the KDCA and the Contract for **“Construction of Indoor Net facility at Sri. Gujarati Vidyalaya Higher Secondary School, Kozhikkod.”** is awarded to the Bounden, the Bounden shall within 7 days of acceptance of his Tender, execute an Agreement with the KDCA incorporating all the terms and conditions under which the KDCA accepts his Tender.
2. In case the Bounden fails to execute the Agreement aforesaid incorporating the terms and conditions governing the contract, the KDCA shall have power and authority to recover from the Bounden any loss or damage caused to the KDCA by such breach as may be determined by the KDCA, appropriating the Earnest Money deposited by the Bounden and if the earnest money is found to be inadequate, the deficit amount may be recovered from the Bounden and his properties, movable and immovable, and also in the manner hereinafter contained.
3. All sums found due to the KDCA, under or by virtue of this agreement shall be recoverable from the Bounden and his properties, movable and immovable, under the provisions of the PREVAILING LAW for the time being in force and also in such other manner as the KDCA may deem fit.
