2. The EMD of INR.1,00,000/- should be in the form of DD in favour of Kerala Cricket Association, Thiruvananthapuram, payable at Thiruvananthapuram. Bid document fee of Rs.8,900/- (including GST) should be remitted online to the account number given and UTR receipt should be submitted along the Bid documents. Only Internet Banking is allowed as mode of payment.
3. All the Bid documents are to be send to this office by ***Registered / Speed post/courier only and no manual submission shall be entertained. Late tenders will not be accepted.***
4. The copies of bid agreement executed in Kerala stamp paper worth Rs.200/- Permanent Account Number (PAN), GST registration certificate with signature duly affixed and Experience certificate showing experience in the execution of at least one similar work in Govt/ Public sector undertakings during last 5 years as a contractor shall be submitted along with the tender. The GST REGISTRATION CERTIFICATE shall be submitted along with the tender.
