The tender is invited, in three cover system, from the experienced and eligible contractors through registered post / speed post/courier.) Prospective bidders willing to participate in this tender shall submit their tender.

Tender Process:

The tender process shall consist of the following stages:

Downloading of tender document:

- Tender document will be available for free download on www.keralacricketassociation.com
- However, tender document fees shall be payable at the time of bid submission as stipulated in this tender document.
- Bid submission: Bidders have to submit their bids along with supporting documents to support their eligibility, as required in this tender document by registered/speed/ Courier post only. No manual submission of bid is allowed and manual bids shall not be accepted under any circumstances.
- Opening of Technical Bid and Bidder short-listing: The technical bids will be opened, evaluated and short listed as per the eligibility and technical qualifications. All documents in support of technical qualifications shall be submitted. Failure to submit the documents online will attract disqualification. Bids short listed by this process will be taken up for opening the financial bid.
- Opening of Financial Bids: Bids of the qualified bidder's shall only be considered for opening and evaluation of the financial bid on the date and time mentioned in critical date's section.

Cover No.3 – Price Bid

The cover marked as 'Cover Number -3' is meant for - 'Price Bid' and should contain *Tender Schedule* (The Bidder shall complete the Price bid (Tender Schedule) as per format given for download along with this tender.)

Fixed price: Prices quoted by the Bidder shall be fixed during the bidder's performance of the contract and not subject to variation on any account. A bid submitted with an adjustable/variable price quotation will be treated as non-responsive and rejected.

• Tender Document Fees and Earnest Money Deposit (EMD)

The Bidder shall pay a tender document fee of **Rs. 8,900** /-(including GST) and Earnest Money Deposit or Bid Security of **Rs.1,00,000/-**. The Bid security is required to protect the purchaser against risk of Bidder's conduct, which would warrant the forfeiture of security.
