- 1. In case the Tender submitted by the Bounden is accepted by the KCA and the Contract for "Painting Pavilion, Indoor and allied works at Cricket ground, Perinthalmanna, Malappuram" is awarded to the Bounden, the Bounden shall within 7 days of acceptance of his Tender, execute an Agreement with the KCA incorporating all the terms and conditions under which the KCA accepts his Tender.
- 2. In case the Bounden fails to execute the Agreement aforesaid incorporating the terms and conditions governing the contract, the KCA shall have power and authority to recover from the Bounden any loss or damage caused to the KCA by such breach as may be determined by the KCA, appropriating the Earnest Money deposited by the Bounden and if the earnest money is found to be inadequate, the deficit amount may be recovered from the Bounden and his properties, movable and immovable, and also in the manner hereinafter contained.
- 3. All sums found due to the KCA, under or by virtue of this agreement shall be recoverable from the Bounden and his properties, movable and immovable, under the provisions of the PREVAILING LAW for the time being in force and also in such other manner as the KCA may deem fit.
