Kerala Cricket Association invites sealed tenders from reputed and experienced manufacturers/ Authorized contractors to survey, design, supply, installation, testing and commissioning of LED Floodlighting System at Outdoor Practice Wicket Facility at The Sports Hub, Greenfield International Stadium, Thiruvananthapuram.

The tenderer/ applicant having experience in undertaking similar projects with other State Cricket Associations will be given preference.  should contain technical details and Cover II should contain detailed
 BOQ/price quoted.
- Technical bids will be first opened during office hours on 2nd September 2023,
 2 PM
- 4. Commercial bids will be opened of those bidders who meet the qualification criteria as per prevailing KCA norms, at 3 PM, 2nd September 2023
- 5. Earnest Money Deposit

Rs.2,00,000/- by Demand Draft (DD) in favor of "KERALA CRICKET ASSOCIATION" payable at Trivandrum along with submission of bid. The DD should be drawn on a scheduled bank and should be put into a separate sealed envelope with the name of work and name of the bidder clearly written on it referring as "EMD". This envelope should be put in another envelope containing the bid, which should be sealed.

6. Security Deposit

Successful bidder shall furnish Security deposit **@ 5%** of the contract price, by demand draft in favour of "KERALA CRICKET ASSOCIATION" payable at Trivandrum, however, Earnest Money Deposit shall be converted as Security Deposit and difference in amount shall be adjusted accordingly.

Security deposit shall be released after the total retention amount deducted from the successful bidders (hereinafter referred to as "Contractor") bills equals the amount of security deposit.

- 7. Performance Bank Guarantee: Successful bidder shall submit Performance Bank Guarantee @ 5% of contract price, validity shall be initially for one year thereafter shall be extended covering Defect Liability Period (DLP) & performance period of 3 years based on final decision of the tendering authority.
- 8. Commencement of work: Immediately from the date of issuance of work order.
- 9. Time frame: The time frame for the completion of work shall be 20 days from the date of issuance of work order.
- 10. Proposal for AMC (Annual Preventive Maintenance) should be shown separately.

Retention: Retention money @ 5% of the gross value of work certified in each bill shall be deducted progressively.

Retention money shall be released at the end of the Defect Liability

Period/Guarantee Period after all the defects, if any, have been rectified. Retention amount can also be released against Bank Guarantee submitted by bidder for the stipulated performance guarantee period. This will be without prejudice to all other rights and/or claims of Kerala Cricket Association relating to the quality of work done by the Contractor.

Defect liability period: 12 months from the date of the final bill / Handing over of complete system as certified by the Consultant for entire work.

Warranty: The bidder to submit the authorization letter from Original Equipment Manufacturer (OEM) with EOI /Tender reference undertaking the responsibility for design, supply, installation and commissioning of sports lighting systems and its performance. The OEM should also provide a warranty against manufacturing defects for a period of 5 years from date of invoice.

Right of acceptance/rejection: KCA reserves the right to accept any bid or reject any or all bids or to postpone or cancel the work without assigning any reason to do so and does not bind itself to accept the lowest or any bid.
