Kerala Cricket Association invites Tender / Quotation for providing double piece blow **molded high density poly ethylene bucket Stadium Chairs** with shared armrest between seats and with or without cupholder (front floor mounted/Riser mounted- tip up) (hereinafter referred as **STADIUM CHAIRS**) at The Sports Hub, Greenfield International Stadium, Karyavattom, Thiruvananthapuram from reputed firms/ agencies/companies having registrations, and having experience in the field for a minimum period of Ten years or more. Scope of the Supply/Service:

Supplying, fitting & fixing of two piece blow molded high density poly ethylene Tip up stadium chairs of smooth matte finish and legs made of aluminum precision die casting, seat and backmade seat foot is fastened on cement boards and concrete floor through appropriate bolting mechanism, armrest in PP with cupholder, static load of seat surface 2000N, 20X static load of chair 960n, 20X seat durability, weather resistance and high temperature resistance test (100+/-) 5 C 120h. The seats should conform to the preferred posture and support movement as per modern ergonomic studies.

- b. **STADIUM CHAIRS** shall be installed and made functional 1 week before the deadlines given in the tender document.
- c. **STADIUM CHAIRS** shall be installed to the satisfaction of Kerala Cricket Association.
- d. The contractor shall ensure replacement of any faulty CHAIR within 2 DAYS of their being identified. Contractor may keep adequate reserves at site. The contractor is required to maintain the chair for next six month after completion.
- e. Maintenance team of required engineers to be stationed at The Sports Hub, Greenfield International Stadium, Karyavattom, Thiruvananthapuram during installation and commissioning of the Chairs.
- g. Kerala Cricket Association shall not be held responsible for any loss or damage to the **STADIUM CHAIRS** supplied by the Contractor prior to installation.
- h. The Bidder shall ensure that all statutory compliances for its personnel are its responsibilities.
- i. The bidder should give assurance about the availability of the same model chair for 3 years after the defect liability period.

The rates should include the transportation, fixing of NEW CHAIRS.

All statutory taxes, fees, etc. of any kind shall be borne by the Bidder.

INSTRUCTIONS TO THE BIDDER

1. Please read the Terms & Conditions carefully before filling up the document.
2. Incomplete Documents will be rejected. It is in the interest of prospective Bidder that they may inspect the Premises /location prior to submission of their bids.
3. Kerala Cricket Association reserves the right to obtain feedback from the previous / present clients of the Bidder and also depute its team(s) to inspect the site(s) of their present contract(s) for on-the-spot first-hand information regarding the maintenance and other related services provided by the Bidder. The decision of the Kerala Cricket Association in this regard will be final and binding on all bidders.
4. Eligibility Conditions:
 - a. The Bidder should be in the same field of supply, installation for a minimum period of TEN years as on date of submission of tender.
 - b. The Bidder shall ensure that adequate technical support is available.
 - c. The Bidder should have installed at least 10,000 seats in international cricket stadiums in India.
5. Each page of the tender should be signed by authorized signatory.
6. Bidder shall have to submit a sample of the proposed chair to Kerala Cricket Association within 2 days from date of bid submission.
7. The sealed envelope should be dropped in the Tender Box.
8. The Bidder shall coordinate with all concerned authorities.
9. The necessary details / clarification if any can be obtained from KCA Office between 10.00 AM to 05.00 PM on any working day.
10. All quotations / offers / Tenders should be in the format given at **Annexure 'A'** with signatures of authorized signatory and stamp of Company / Firm / Organization.

11. **An Earnest Money Deposit (EMD) of Rs.2 lakh (Rupees Twenty Lakh Only) in the form of Bank Draft or proof of remittance through RTGS in favour of Kerala Cricket Association shall be submitted by all bidders. The Bank Draft will be favoring Kerala Cricket Association payable at Ernakulam (bank details for RTGS may be obtained from the Office of Secretary, Kerala Cricket Association (0471 2326522). All quotations submitted without EMD shall be rejected. EMD amount shall be refunded to unsuccessful Bidders within a week of opening the commercial bids. EMD shall be submitted by all bidders** along with PAN No. / TAN No. / GST Number and I.D. Proof with Company / Organization / Firm's details of Registration, Memorandum & Articles, Partnership / Proprietorship details as the case may be.
12. The vendor / contractor must visit the stadium to check all items / requirements for tender.
13. Kerala Cricket Association reserves its right to award the work to multiple vendors at the L1 rate.
14. The Secretary, Kerala Cricket Association reserves its right to accept or reject any of the offers or cancel all offers and also modify conditions of effect any other change in items, terms and conditions.

Fastening:	Tamper proof anchor fasteners for grouting to concrete or as per actual site requirement.
