The Kerala Cricket Association is a society registered under the Travancore, Cochin, Literary, Scientific and Charitable Societies Registration Act, 1955 (Act XII/1955) Registration No. 468/88 having its Headquarters at KCA Complex, Sasthamkovil Road, Thycaud, Thiruvananthapuram. KCA is an affiliate of BCCI. The aims and objectives of the KCA is to promote, popularize, conduct and control cricket in the State. In view of this, Kerala Cricket Association decided to conduct T20 Premier League and to appoint agencies/ companies who specialized expertise in conducting similar tournaments/ events.

Accordingly, the expression of interest is invited from all the firms/companies for the following services (herein after services)

- a. Tie up with a reputed TV broadcaster and OTT platform.
- Live broadcast Television production with international standard quality, including graphics and commentary team.
- c. Live streaming production on OTT.
- d. Production towards sponsorship / venue branding.
- e. Sportainment and fan engagement activities.

TERMS AND CONDITIONS

1. **ENVELOPE "A": TECHNICAL BID** to be submitted in a separate cover super scribed engaging **AGENCIES/ COMPANIES FOR CONDUCTING KERALA T20 PREMIER LEAGUE -TECHNICAL BID"** and should contain the following.

Only the successful Technical Bidders will be considered for the Financial Bid.

- a. The Registration details of the tenderer/firm/company along with necessary documentary proofs showing valid legal status.
- b. Name and addresses of all the directors/proprietors of the firm as it stands on the date of application.
- c. Name and address of the bankers of the firm/company.
- d. GST registration details of the firm/ company.
- e. PAN number of the firm and its directors/proprietors.
- f. The participant must be an entity of good repute with a proven track record in providing the above services in the last five (5) years.
- g. The Participant should have an annual turnover of not less than average of Rs. Fifty (50) Crores for the last three consecutive years.
- h. The Participant should have at least five (5) years' experience managing T20 Tournaments for State Cricket Associations in India and should have similar existing contracts with at least five (5) state cricket associations affiliated to BCCI.
- Companies /firm against whom a complaint has been registered with the
 CBI, Serious Fraud Investigation Cell will not be considered.
- j. An affidavit by the authorised person of the firm/agency/company to the effect that none of the partners/directors/ proprietors/ employees is/are a member of the KCA/sub committees of KCA/ or is/are barred by the BCCI rules on Conflict of Interest.

2. **ENVELOPE "B":** to be submitted in a separate cover super scribed **AGENCIES/**

COMPANIES FOR CONDUCTING KERALA T20 PREMIER LEAGUE -FINANCIAL BID and

should contain the following.

Only the successful technical bidders will be considered for the financial bid.

a. The financial bid (amount) for the services of T20 Premier League to be offered.

b. The amount for above services quoted will be exclusive of GST and GST has to be

shown separately.

c. All taxes and levies by the local bodies like corporation, municipality, panchayat

etc are to be paid by the bidder.

d. Letter of acceptance of all the terms and conditions and clauses mentioned in

the tender document.

e. All the bidders are advised to depute their authorised representatives present

during the opening of the tender.

f. Tenders once submitted cannot be withdrawn.

g. The successful bidder has to enter into an agreement with KCA on receipt of

awarding the work.

KCA reserves the right at its discretion to reject/accept any tenders, cancel or retender

without assigning any reasons whatsoever and amend /alter the terms and conditions of the

tender for the benefit of KCA.

The selection for empanelment of the firms / companies shall be taken up through the

committee appointed by KCA.

GENERAL CRITERIA FOR EMPANELMENT AGENCIES/ COMPANIES FOR CONDUCTING KERALA T20 PREMIER LEAGUE

SELECTION PROCEDURE: -

The EOI in sealed cover along with all necessary documents shall be sent to the undersigned through registered post/speed post/ courier/ by hand so as to reach Hon' Secretary, Kerala Cricket Association, KCA Headquarters, Sasthamkovil Road, Thycaud, Thiruvananthapuram on or before 5 pm on 21.05.2024.

- 1. All applications shall be submitted in the prescribed format.
- 2. Once empaneled company/firms will remain unless and until company / firms is removed by KCA.
- 3. All applications need to be accompanied with relevant documents to substantiate the qualifications, registration and experience etc.

OTHER GUIDELINES: -

Kerala Cricket Association may disqualify the applicants at any stage for the following reasons:

- Non-fulfillment of above qualification conditions.
- Incomplete / part information/ misinformation (without supporting proof).
- Exerting external influences.
- Late EOI applications.
