➤ Terms and Conditions

1. All Communications shall be addressed to the Secretary, Kerala Cricket Association, K.C A Complex, T.C-28/152, Sasthamkovil Road, Thycaud, Thiruvananthapuram, 695014 only.
2. The EMD of INR.25,000/- should be in the form of DD in favor of Kerala Cricket Association, Thiruvananthapuram, payable at Thiruvananthapuram Bid document fee of Rs.2,950/- (including GST) should be remitted online to the account number given and UTR receipt should be submitted along the Bid documents. Only Internet Banking is allowed as mode of payment for Bid document fee.
3. All the Bid documents are to be send to this office by ***Registered / Speed post/Courier only and no manual submission shall be entertained. Late tenders will not be accepted.***
4. The copies of bid agreement executed in Kerala stamp paper worth Rs.200/-, Permanent Account Number (PAN), GST registration certificate with signature duly affixed and Experience certificate showing experience in the execution of Civil works in Govt/ Public sector undertakings as a contractor and shall be submitted along with the tender. The GST REGISTRATION CERTIFICATE shall be submitted along with the tender.
5. The Pre-qualification Bid shall be opened at Head Quarters of Kerala Cricket Association, K.C.A Complex, T.C-28/152, Sasthamkovil Road, Thycaud, Thiruvananthapuram, 695014 on the date and time mentioned above. If the date fixed for opening of tenders happens to be a holiday, tender shall be opened on the next working day atthe same time.
6. Before filling up the tenders, the bidders may note the following:
 - a. The tenderer should quote the rates in figures as well as in the words. The rate for each item should be worked out and the requisite total amount shall be calculated accordingly. Rates quoted by the bidder in item rate tender in figures and words shall be accurately filled in so that there is no discrepancy in the rates, figures and words. However, if a discrepancy is found in the rates in words and figures, then the rates quoted in words shall be taken as correct.
 - b. The tenderers must include in their tender prices quoted for GST transportation charges, loading and unloading charges, Labour charges and any local charges etc. if applicable. No extra claim on this account will in any case be entertained.

- c. The tender document must be filled in English. Incomplete tender documents shall be considered invalid except in cases where additional details can be called for, if the tendering authority decides to call for- to substantiate the bid submission.
- d. All taxes including GST or any other payable/ prevailing tax on material or on finished works etc. or insurance cost, transportation etc., in respect of this contract shall be payable by tenderer and the KCA will not entertain any claim whatsoever in this respect over the quoted price.
- e. **The tender will be conducted as an open tender under the Design and Build format, enabling bidders to propose innovative and technically sound proposal for the Indoor Cricket Practice Nets.**
- **Scope of Work Includes:**
- **Construction of Concrete Wickets**
 - **Structural Frameworks including roofing**
 - **Supply and Installation of HDPE Nets**
 - **Astroturf Works**
 - **Other Works including Land Development, RCC & PCC Works, Foundation works, Masonry Works etc...**
- f. Bidders must clearly justify their choice of solutions for the specific site conditions in their reports.
- g. So as part of the bidding process, Kerala Cricket Association (KCA) invites proposals from reputed and experienced agencies for the **Design, Supply, and Installation of Framed Indoor Cricket Practice Nets at Government Brennen College, Kannur.**
- h. The bidders are requested to propose **Customized Indoor Cricket Practice Nets** for the specific areas marked in the drawing attached to this request. All technical requirements and indicative alignment details are included in the drawing for your reference.

Proposal Submission Requirements:

Interested bidders are requested to submit a comprehensive proposal that shall include the following:

- ***Design Proposal:*** *A complete Indoor design suited to the site conditions, with*

justification for the chosen design based on functional and aesthetic factors, along with the estimated life span and durability in local climatic conditions.

- ***Execution Plan:*** *An execution plan detailing the installation methodology, tentative timeline, site preparation, erection process, and post-installation finishing.*
- ***Material Specifications:*** *Material specifications including details of all materials proposed—such as grade, finish, protective coating (if any), structural strength—along with manufacturer information and applicable warranty details.*
- ***Supporting Documents & Illustrative Representations:*** *Supporting documents including photographs and brief descriptions of similar Indoor works executed by the bidder, along with credentials, experience, and relevant project references.*
- ***Quality & Safety Measures:*** *An outline of safety protocols, quality control measures, and adherence to relevant standards.*
- ***Cost-Efficiency & Sustainability:*** *Evaluation of the most cost-effective and durable solution tailored to the site's needs.*

i. Bidders proposing indoor practice nets must include detailed drawings of their proposed design as part of their bid submission.

j. Selection Process: The final selection of the contractor will be based on the technical viability, cost-effectiveness, and feasibility of the proposed solution.

k. Before quoting, **the tenderer shall inspect the site**, to fully acquaint himself about the condition in regard to accessibility of the site, working condition of site, locality including installations of tools and plants (T&P) and local authority regulations / restrictions if any, conditions affecting accommodations and movement of personnel etc. required for the satisfactory execution of the work contract. **No claim whatsoever on such account shall be entertained by the KCA in any circumstances.**
