1. Introduction

Kerala Cricket Association (KCA) invites Expressions of Interest (EOI) from reputed, experienced and eligible firms/agencies/companies for the Design and Supply of Stadium Chairs at the Sports Hub, Greenfield International Stadium, Karyavattom, Thiruvananthapuram.

The EOI is intended to shortlist competent agencies with proven experience for participation in the subsequent tendering process.

2. Scope of Work

- The scope shall broadly include:
- Supply of two-piece blow moulded high-density polyethylene (HDPE) tip-up stadium chairs
- Chairs with shared armrest, with or without cup holder
- Front floor-mounted / riser-mounted installation as per site conditions
- Chairs shall be ergonomically designed, weather-resistant and suitable for outdoor stadium use
- Static load, durability, temperature resistance and performance requirements as per international standards
- The contractor shall supply stadium chairs and provide necessary support for installation, if required.
- The final scope, quantity and technical specifications shall be detailed in the tender document.

3. Eligibility Criteria

Interested agencies should meet the following minimum requirements:

- Minimum 10 years of experience in supply and installation of stadium seating systems

- Prior experience in supplying and installing at least 10,000 stadium seats in international cricket stadiums in India
- Availability of adequate technical manpower and after-sales support
- Should not have been blacklisted by any Government or reputed private organization
- Should comply with all statutory requirements applicable in India

4. Site Visit Requirement

Firms must visit the site prior to submitting the proposal in order to understand the existing layout and practical conditions.

5. Submission Requirements

The bid proposal must be submitted in a sealed cover or via email, clearly labelled “EOI – Design and Supply of Stadium Chairs at the Sports Hub, Greenfield International Stadium, Karyavattom, Thiruvananthapuram.” And should include:

- ii. Legal status of the firm (Proprietorship / Partnership / LLP / Company, etc.)
- iii. Experience details with similar works executed (completion certificates preferred)
- iv. Statutory registrations:
 - PAN
 - GST Registration
 - Firm/Company Registration
- v. Contact details of authorized representative
- vi. Brief technical brochure/details of proposed stadium chair model(s) along with the detailed cost estimate showing all necessary breakup such as supply of material, installation charges, transportation and other associated works (if any), taxes etc.

- Price validity for a period of 3 months (no price escalation will be entertained)
- KCA may negotiate rates before final award.
- Submission of EOI does not guarantee selection or award of work
- No cost incurred for preparing the proposal shall be reimbursed.
