#### **1. Introduction**

Kerala Cricket Association (KCA) invites Expressions of Interest (EOI) from experienced and competent agencies for supply and installation of signages at the KCA Cricket Ground, Mangalapuram.

#### **2. Scope of Work**

- The selected agency shall be responsible for the supply, installation, and commissioning of signages strictly in accordance with the designs, drawings, and specifications provided and approved by Kerala Cricket Association (KCA). Only KCA-approved designs shall be used for execution.
- The agency shall possess all valid licenses, registrations, and statutory authorizations required to carry out the above works and shall comply with all applicable rules and regulations.
- The scope of the contractor shall include obtaining all statutory approvals, permissions, and No Objection Certificates (NOCs) required for placing signages on public roads and other applicable locations.
- All documents, drawings, and supporting details required for obtaining such approvals may be collected from the KCA Office.

- The proposal submitted by the agency shall explicitly include the scope, responsibility, and cost (if any) related to obtaining statutory approvals and NOCs.
- The quoted rates shall be all-inclusive, covering supply, fabrication, installation, transportation (if any), tools, labour, and all incidental charges.
  - GST shall be quoted separately in the financial proposal.
- The agency shall have adequate human resources, technical capability, and infrastructure to execute the works efficiently and to cater to last-minute or urgent requirements, if any, as instructed by KCA.
- Any additional works or quantities, if required, shall be undertaken only against a valid written Work Order or approval issued by KCA.
- The contractor shall deploy a dedicated team exclusively for KCA for the execution, coordination, and timely completion of the above works.

Firms must visit the site prior to submitting the proposal in order to understand the existing layout and practical conditions.
