1. Introduction

Kerala Cricket Association (KCA) invites Expression of Interest (EOI) from qualified, experienced, and licensed MEP Consultancy Firms for empanelment to provide consultancy services for various infrastructure development works across Kerala.

2. Scope of Services

The empanelled consultants shall provide consultancy services including but not limited to:

- Mechanical, Electrical and Plumbing (MEP) design and engineering
- Preparation of drawings, estimates, and BOQs
- Project planning and coordination
- Site supervision and quality monitoring
- Assistance in tendering and contractor selection
- Any other allied consultancy services

Projects may include stadiums, cricket grounds, training facilities, office buildings, and other infrastructure projects of KCA.

3. Term of Empanelment

The empanelment shall be valid for a period of **3 (Three) years**, extendable based on performance and requirements of KCA.

4. Eligibility Criteria

Applicants must satisfy the following:

- Minimum 5 years of experience in MEP consultancy
- Valid statutory registrations and licenses
- Experience in sports infrastructure / institutional / commercial projects
- Adequate technical manpower and organizational infrastructure

5. Submission Requirements

Interested firms shall submit their proposal along with the duly filled application (Annexure A), including the following details:

- Firm profile and organizational structure
- Details of relevant project experience
- Work orders / completion certificates
- Client list
- Financial statements for last 3 years
- Details of key personnel
- Statutory registrations and certifications

7. Evaluation Methodology

Stage 1: Preliminary Screening

Applications will be screened on a pass/fail basis for eligibility and completeness.

Stage 2: Technical Evaluation (100 Marks)

Applications will be evaluated based on the following criteria:

- Relevant Experience – 30 Marks
- Key Personnel & Team Strength – 20 Marks
- Quality of Past Work – 15 Marks
- Technical Capability & Approach – 15 Marks
- Financial Strength – 10 Marks
- Organizational Capacity – 10 Marks

Applicants securing a minimum of **60 marks** may be considered for empanelment.

KCA reserves the right to conduct presentations/interactions, if required.

8. Empanelment & Allocation of Work

- Empanelment does not guarantee award of work.
- Assignment of projects will be based on project requirements, consultant expertise, and internal policies of KCA.
- KCA may adopt rotation, nomination, or limited tendering among empanelled consultants.

9. Performance Review

Continuation in empanelment shall be subject to periodic performance review.

Applicants shall disclose any conflict of interest. KCA reserves the right to disqualify applicants in case of non-disclosure.
