

FORM OF BOUNDEN AGREEMENT

Articles of Agreement executed on this day of.....Two Thousand and Twenty six Between the KERALA CRICKET ASSOCIATION acting through the Secretary, Kerala Cricket Association, K.C.A Complex, T.C-28/152, Sasthamkovil Road, Thycaud, Thiruvananthapuram, 695014 , hereinafter referred to as ‘the KCA’ of the One Part And Sri/Smt

hereinafter referred to as ‘the Bounden’ of the Other Part.

WHEREAS in respect of the invitation for tenders, contained in Notification No..... /2026 /
dated..... inviting tenders, the Bounden has submitted to the KCA a Tender for the work
**“Construction of RCC Retaining Wall for the Development of Cricket Infrastructure at CMS College
Ground, Kottayam.” specified** therein subject to the terms and conditions contained in the said Tender.

AND WHEREAS the Bounden has also deposited with the KCA a sum ofas Earnest
Money for execution of an Agreement undertaking the due fulfillment of the contract in case his Tender is
accepted by the KCA.

NOW THESE PRESENTS WITNESS AND it is hereby mutually agreed as follows:-

1. In case the Tender submitted by the Bounden is accepted by the KCA and the Contract for
**“Construction of RCC Retaining Wall for the Development of Cricket Infrastructure at CMS
College Ground, Kottayam.”** is awarded to the Bounden, the Bounden shall within 7 days of
acceptance of his Tender, execute an Agreement with the KCA incorporating all the terms and
conditions under which the KCA accepts his Tender.
2. In case the Bounden fails to execute the Agreement aforesaid incorporating the terms and conditions
governing the contract, the KCA shall have power and authority to recover from the Bounden any loss
or damage caused to the KCA by such breach as may be determined by the KCA, appropriating the
Earnest Money deposited by the Bounden and if the earnest money is found to be inadequate, the
deficit amount may be recovered from the Bounden and his properties, movable and immovable, and
also in the manner hereinafter contained.
3. All sums found due to the KCA, under or by virtue of this agreement shall be recoverable from the
Bounden and his properties, movable and immovable, under the provisions of the PREVAILING LAW
for the time being in force and also in such other manner as the KCA may deem fit.
